General Participation Requirements

- Location must be on government owned property
- Location must be well-lit and safe for a charging station
- Location should be highly visible
- Station must be accessible to the general public
- Agree to be part of ChargeWell network

Steps for Participation

- Complete application and submit photo(s) of installation site(s)
- Plug-in Electric Vehicle working group will evaluate all applications
- Allow potential charging station vendor a site visit to estimate installation costs
- Sites ranked and awarded until CMAQ funds exhausted
- Installation of charging stations will be done through selected vendor (RFP Process)
- Final inspection
- The North Florida TPO will reimburse the contractor.

Terms & Conditions

- Applicant will own and operate and maintain the charging station(s).
- Installation location must be on agency's premise with an active electric service account.
- Must participate in the ChargeWell Network including display of ChargeWell logo on charging equipment.
- Equipment is not to be re-sold or re-distributed without consent of ChargeWell network. Owner will notify ChargeWell network of ownership changes.
- Charging station equipment must be well-lighted and accessible to the general public
- Equipment recipients must agree to not charge more than \$0.25/kWh for at least the first 24 months after the installation is completed.
- Recipient must clearly mark EV spot to designate electric vehicle parking space and charging station according to ChargeWell specifications. Recipient is responsible for providing security to area and charging station equipment.
- Award recipient acknowledges that Florida law (s. 366.94(3)) stipulates that it is unlawful for a person to stop, stand, or park a vehicle that is not capable of using an electrical recharging station within any parking space specifically designated for charging an electric vehicle. If a law enforcement officer finds a motor vehicle in violation of this subsection, the officer or specialist shall charge the operator or other person in charge of the vehicle in violation with a noncriminal traffic infraction, punishable as provided in s. 316.008(4) or s. 318.18.
- Award recipient agrees to maintain equipment in working condition.
- All equipment will be installed to manufacturer specifications, comply with all applicable codes and be installed by Florida registered-licensed electricians.
- Final installation is subject to final inspection process and documentation.
- North Florida TPO does not endorse any specific manufacturer or dealer and makes no representations regarding specific manufacturers or dealers or their workmanship.
- North Florida TPO makes no warranty for the charging station equipment; manufacturer warranty will apply.
- North Florida TPO will not be responsible for any property damage or bodily injury resulting from installation and use of charging station equipment. Customer will release, indemnify, and hold harmless the North Florida TPO from any and all claims, demands, losses, expenses, damages, attorneys' fees, judgments, costs, and legal liability arising from or related to the Customer Terms and Conditions, the ChargeWell Program or any services or products provided thereunder, regardless of any strict liability or negligence of the North Florida TPO, whether active or passive, excepting only such claims as may be caused by the gross negligence or willful misconduct of electric delivery.
