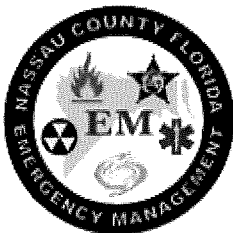

Subject: Notice of Local Road Closure for Preparedness Exercise - Nassau County - March 22nd

Good afternoon, ladies and gentlemen.

This email is intended to serve as a notice of temporary local road closure on **Wednesday, March 22nd from approximately 8:00 AM – 2:00 PM.**

The affected area is from **Goodbread Road at the intersection of Pages Dairy Road to Goodbread Road at the intersection of Koen Lane** in the vicinity of the Yulee Sports Complex. The area will be closed via Road & Bridge Department barricades and NCSO deputies' patrol vehicles.

The purpose for the closure is to accommodate a public safety exercise concerning an active threat on the campus of Yulee Primary School. First responders will stage at the Yulee Sports Complex and respond into the simulated crime scene. Emergency vehicles will traverse back and forth between the school and staging area throughout the exercise which is scheduled for the hours of 9:00 AM – 1:00 PM. The intent is to restrict access to members of the public who may become exposed to unnecessary risk by being present within an active exercise area.

The following additional precautions are being implemented:

- Exercise signage is being placed along the roadway
- Exercise safety personnel will be on-site at both the staging area and the venue
- A press release is being prepared for distribution through standard protocol
- Public notice signs will be posted at the Yulee Sports Complex 48 hours preceding the exercise
- A public notice will be posted to social media platforms in regular use (Facebook & Twitter)
- Everbridge notifications will go out to key partners (i.e. School Board and Baptist Nassau)
- The State Watch Office and Regional Coordinator will be made aware of the exercise
- Contiguous counties will be made aware of the exercise – Baker and Duval Counties

If you have any objections to this temporary road closure, please make them known before close of business on **Friday, March 3rd** in order to allow enough time to develop another workable solution.

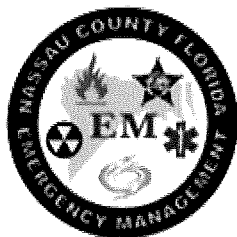
