- Ordinance 2003-17, Section 6.03, discard, place trash, litter or debris
- Ordinance 97-19, Section 28.15, accessary uses and structures
- Administrative fees of \$348.38 to be paid by July 14, 2015
- Fine of \$50.00 per day started July 14, 2015
- Compliance date November 14, 2016 accrued for 489 days x \$50.00 = \$24,450.00
- \$24,450.00 (fine) + \$348.38 (administrative fees) = \$24,798.38 (total)
