Mr. Mullin,

You asked Engineering Services to estimate what Sfage is still needed from residents on Dyal Road. I attached a map showing the 4 fours properties that have not sent a response to NC on our request to acquire the ROW. As shown on the map, there are four properties owned by:

\*36766 and 36784 Dyal-Mary Erwin (and Glenda Fires for #36784)

The properties are all neighbors along the eastern side of the roadway and with a 10'wide strip of ROW-approximately 19,300 SF of ROW is needed (see the attached map). The BOCC asked you to estimate the cost and process for condemnation of ROW on this portion of the roadway. Attached is the approximate SFage needed for the four properties.
