### **Air Conditioning Replacement Program - Other County Facilities / Parks:**

- Bryceville Ball Park – Replace HVAC Unit. (JN)
- Facilities Maintenance Office – Replace HVAC Unit (DB)
- Fire Rescue Headquarters – Replace HVAC Split System (LB)
- Fire Station 20 – Replace 3 HVAC Units (LB)
- Fire Station 30- Replace a 5 Ton unit and make repairs to Duct Work. (JN)
- Historic Courthouse Replace 2 Units and 1 Humidifier. (LB)
- Yulee Health Clinic: Replace 2 HVAC Systems. (JN)

### **Peters Point Park:**

- Stabilization of Retaining Wall
  - Engineering complete.
  - Schedule for completion in 90 days.

### **Public Service Building:**

- Replace Existing Re-Circulating water lines. (Fix ceiling water leaks.)

### **Yulee Sports Complex:**

- Gym Renovations – 60% complete Doors have been delivered.

### **Emergency Operations Center:**

- **War Room -Engineering -Re-ducting the 10 Ton System.**
  - Plan being re-evaluated to use Mini Split System.

### **Facilities Maintenance Administration:**

- **Actively working on building the Dude Solutions – Asset Essentials Data**
- **Researching a Time Clock System.**
- **Upgrading the Mobile Phone Service.**
