

### **Canopy Road Designation**

#### What does a Canopy Road/Scenic Road Designation mean?

Nassau County Land Development Code Section 37.08 (D to K) address the restrictions (section 37.08 B) and procedures for appeal, violation and conflict (sections L-K) regarding Canopy/Scenic roads.

- Roadway cannot be widened
- Advertising and billboard signs are prohibited
- Sign posted stating the Canopy/Scenic Road status.
- Speed limit set and posted
- Sign posted warning of restricted use of roadway shoulders
- Limitation of class of vehicle that can use the roadway by weight and height.
- Access limitations
- Tree protection measures which limit removal of any tree which attains a diameter of eight inches or more at a height of 4 1/2 feet above average ground level except as set forth in section 37.08 D. Trees identified in Florida's Most Invasive Species List, Category I can be removed without a permit.
- Nothing can be built within the zone except by approval of the Board of County Commissioners after submission to the planning department.
- Requests for removal of trees within the protected zone must be submitted to the Planning Department who will conduct on an-site inspection and approved by the Board of County Commissioners.
- Removal requests must be accompanied by a mitigation plan which includes the why the tree must be removed, analysis of the effects tree removal will have on the tree canopy and a replanting and management plan.

## **Canopy Road Designation**

## Procedures Necessary to Designate a Canopy/Scenic Road.

Nassau County Land Development Code Section 37.08 allows for the designation of roads or portion of roads as Canopy/Scenic roads. This ordinance defines the procedures for designation (section 37.08 A and C), and states restrictions (section 37.08 B), placed on the Canopy Road after designation. The Planning Department may recommend or Nassau County residents may request a road or portion of road be considered based on criteria set forth in section 37.08 (A).

#### Criteria:

(1) historic significance; (2) scenic criteria (including tree canopy); (3) ecological significance; (4) length and current width; (5) land use map designation; (6) zoning of the property within the area; (7) traffic information.

#### Procedure for Request and Designation:

- Submittal of a petition with signatures of either fifty-one percent (51%) of the property owners abutting the road or signatures of 200 of the property owners abutting the road, whichever is lesser.
- Tree Inventory which identifies and records all trees within the ROW and protection zone.
- Review and comment made by Planning Department and submission of a Report to the Planning and Zoning Board and the Board of County Commissioners which includes the criteria response, suggested conditions, the tree inventory and draft ordinance.
- Public hearing held before the planning and zoning board which will then make a
  recommendation to the Board of County Commissioners. Notice of the Public
  hearing will be mailed to all residents abutting the roadway and published and
  posted as a public notice at least twenty days before the public meeting is held.
- The board of county commissioners must approve the Tree Inventory and can then designate the canopy/scenic road by adoption of an ordinance which will note the width of the protected zone and include the Tree Inventory. The protected zone will be determined by the Board of County Commissioners.
