**RS190821 - 9:41:16 (Tab U)** Discussion of the Park and Recreation Impact Fee Study.

**Discussion:** Mr. Pope explained that this is a follow up workshop from the workshop held on July 29, 2019. He noted that the following was addressed at the July 29, 2019 workshop: What is an impact fee, the number of impact fees that Nassau County has, and who controls those impact fees. He stated that the Board directed staff to reassess the development review and impact fees. He advised that the development review fee study was adopted in March 2019; the parks and recreation impact fee study is complete with a target adoption date of October 14, 2019; the fire, law and admin. impact fee has a target adoption date of December 2019; and the mobility fee plan is undergoing a complete overhaul with a target adoption date of competition of April 2020. He reminded the Board that the methodology used is the Asset in this study Reproduction/Replacement Approach. He reviewed the outcome of the study showing what the impact fee for recreation for single-family homes, duplexes, multi-family homes, and mobile home, mentioning the fee difference by housing type. He provided copies of the study; a chart referencing a hypothetical home in Yulee; comparison chart for impact fees in Nassau, Clay, St. Johns, and Duval counties; and a table referencing St. Johns County tier system. He commented that based on the localized date for Nassau County the impact fee should be based upon per unit fee.

Steven McDonald, Chief Economist, GAI Consultant, came forward to provide information regarding the impact fee study. He commented that the purpose of the study performed by GAI Consultants was to provide the opportunity to make sure the goal is appropriate, legally defensible, fair, and equitable impact fee to provide enough funds to provide the proper capital and infrastructure to serve the park and recreation needs of the county. He explained the methodology and calculations used for the study. He stated that the 1.5 percent adjustment is to ensure that the County does not fall short on funding for parks and recreation and can maintain. The group had further discussion regarding the 1.5 percent adjustment. Mr. Pope reviewed the schedule for the draft ordinance.
