Mr. Dixon,

We have been working with the school to relieve issues related to parking in neighborhoods, blocking driveways, etc. One problem that may be an easy fix is the removal of the No Left Turn sign at the south entrance on the west side of the school as parents drive northbound from Lime Street. The established protocol instructs parents to drive westbound on Lime Street and turn right into the drop off / pick up lanes. Some parents drive eastbound and then try to jump those in the longer line by turning in front of the proper queue.

I'm not sure when or why the sign was taken down, but would like to request that you consider erecting a sign at that location for that purpose, so that our officers have more obvious weight when they instruct eastbound traffic to continue past the driveway and to enter the westbound line at the back. As it is we are experiencing a great deal of congestion when non-school vehicles attempt to navigate this stretch of roadway, and angry parents who are put off by those that jump the line or block the roadway.
