WHEREAS, the parties desire to amend and extend said Agreement.

NOW, THEREFORE, for and in consideration of the promises and mutual covenants and understanding contained herein, the parties hereto do mutually agree as follows:

- 1. This Agreement shall be effective for the period October 1, 2019 through September 30, 2020, unless terminated by either party upon thirty (30) days written notice to the other party, subject to completion of all previous and outstanding billings.
- 2. The funding for Fiscal Year 2019-2020 shall be One Hundred-Fifty Thousand Dollars (\$150,000.00), which shall be paid in quarterly installments of Thirty-Seven Thousand Five Hundred Dollars (\$37,500.00), during the months of December, February, May and August of the fiscal year.
- 3. All other provisions of the Agreement not in conflict with this Amendment shall remain in full force and effect.
- 4. Time is of the essence.
