SUMMARY OF REQUEST AND BACKGROUND INFORMATION

The Amelia Concourse Phase III subdivision consists of 172 single family homesites on a total of 77.44 acres divided into Units A, B, and C, zoned Residential Single Family-2 by ordinance R03-036.

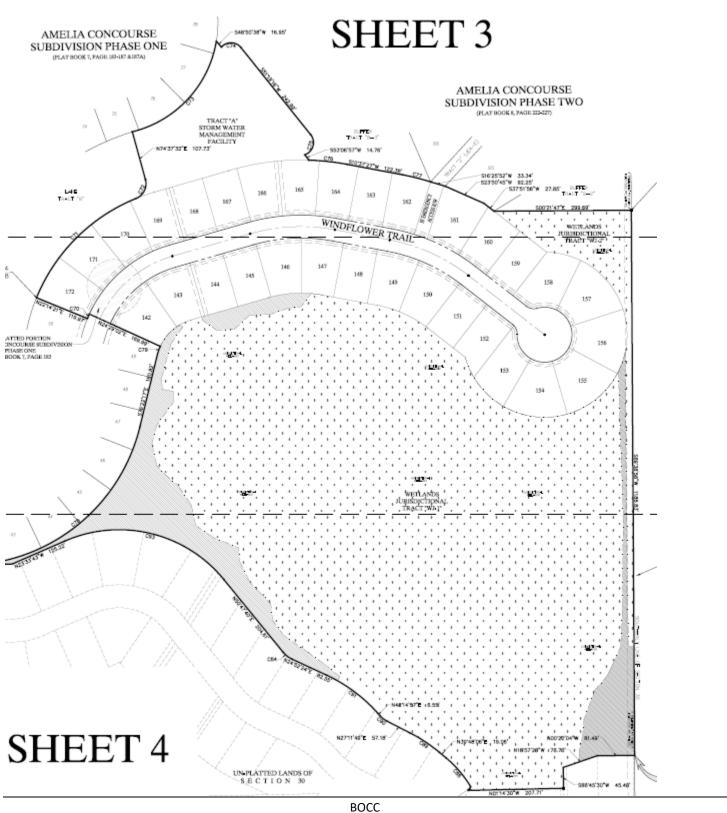
Amelia Concourse Phase III, Unit A consists of 30.11 acres being developed into 31, quarter-acre, single-family lots and 5 tracts. Landscape buffers, sidewalks and street lighting are included in the amenities.

The owner, DFC Amelia Concourse Phase III, LLC, and agent, McCranie and Associates, filed the preliminary plat application, PL18-014 in August 2017 and it was approved by the Development Review Committee on December 27, 2018. The accompanying Site Engineering Plan, SP18-021, was approved at the same time.

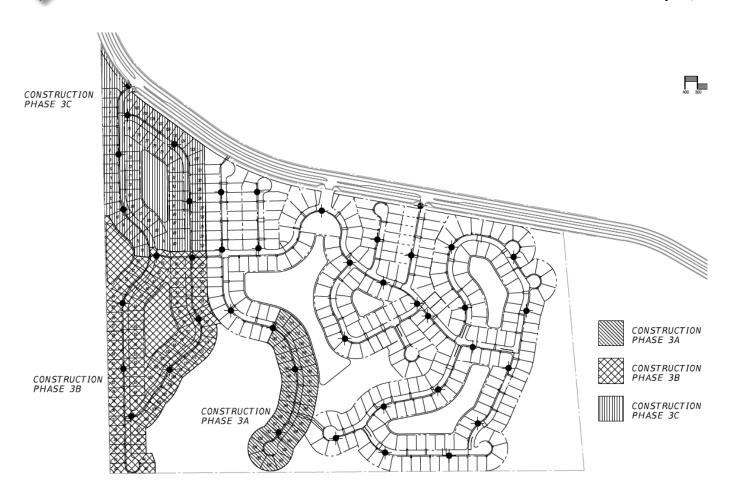
A temporary cul-de-sac that was recorded with the Amelia Concourse Phase One final plat in Book 7, Page 184 will be vacated and replatted with the final plat of Amelia Concourse Phase III Unit A. The purpose of this replat is to eliminate the temporary cul-de-sac that was required for turn-around at the end of Windflower Trail in Phase One. The cul-de-sac will now be abandoned so that Windflower Trail can be continued into the Phase Three portion of the Amelia Concourse subdivision.
