As you may know – the Coalition Board of Directors consists of two Commissioners from each participating member. Also as we prepare to open consideration to confirm Officers and Executive Board members for next year.

During the next month – the Coalition will hold a virtual Board meeting to conduct organizational business. According to the Coalition Bylaws – the Commissioners listed as the Board Representatives from each county will be allowed to participate as a voting member – other commissioners will be able to vote if one of the designated county representatives is not able to participate. We will announce the date of the meeting in the near future.

At this point we are requesting each Coalition member to confirm their designated Board of Directors – this is important to certify who can vote and who is eligible to serve on the Executive Committee as an Officer or as a Regional representative.
