SUBJECT: 2020 ELECTION CYCLE RESERVATIONS OF COUNTY FACILITIES

ITEM 1: APPROVAL OF USE OF BOARD OF COUNTY COMMISSIONERS CHAMBERS FOR 2020 EARLY VOTING PERIODS AND ELECTION DAY.

Section 101.657, Florida Statutes, provides that early voting be conducted in the Supervisor of Elections office. As the Board of County Commissioners Chambers (Chambers) is the only area in the building that is easily accessible to the public and can accommodate large numbers, and in order to comply with Florida law for early voting, I respectfully request use of the Chambers for the time periods listed below. This request is also for the use of the Chambers as a polling place on Election Day. The following dates include set-up of the facility and dates to conduct early voting and Election Day voting.

Presidential Preference Primary: March 5, 2020 at 8:00 a.m. – March 18, 2020 until 11:00 p.m.
Primary Election: August 4, 2020 at 8:00 a.m. – August 18, 2020 until 11:00 p.m.
General Election: October 16, 2020 at 8:00 a.m. – November 3, 2020 until 11:00 p.m.

The following meetings are scheduled for the Chambers during the above time periods. Therefore, we are requesting the following meetings be postponed, canceled or relocated to another facility to assist in the election process. We have reduced the timeframe for set-up and breakdown of the Chambers but, unfortunately, do not have any flexibility with the other dates.

Presidential Preference Primary: March 13, 2020 at 8:00 a.m. – March 19, 2020 at 11:00 p.m.
 Primary Election: August 14, 2020 at 8:00 a.m. – August 20, 2020 until 11:00 p.m.
 General Election: October 30, 2020 at 8:00 a.m. – November 5, 2020 until 11:00 p.m.
