- Provide SJRWMD dewatering permit.
- Provide Geotech report showing HGWL at 55' as documentation of the soil bore is required.
- The 1:4 side slope must be maintained until at least two feet below present water level, or a fence must be installed around the pit. Please update detail for Section A-A.
- Provide haul route for loaded trucks. Haul route must be approved by Engineering Services and a bond in place for possible damage to roadway edge.
