<u>WS200608 - 5:04:51 (Tab A)</u> 5:00 p.m. workshop session for a presentation presented by Dr. David Barth, Barth & Associates, regarding the Recreation Master Plan.

Discussion: Valerie Feinberg, Planning Director, introduced Dr. Barth, Consultant with Barth and Associates, who provided a PowerPoint presentation regarding the June 2020 Interim Report regarding the Parks, Recreation and Open Space Master Plan. The purpose of the Parks, Recreation and Open Space Master Plan is to meet the expected demand for financially viable parks, recreation facilities and programs as a result of the increased population to Nassau

County. Dr. Barth provided a brief overview of the purpose the plan; preliminary implementation framework to identify what the future parks and recreation systems may look like; comprehensive plan; and, benchmarking. Dr. Barth provided a summary of the conceptual long-range parks and open space vision including prototype examples of regional and local parks. He advised that staff has been addressing Impact Fees to fund these multi-purposes regional parks; Bikeways and Trails Master Plan; and, public/private Conservation Lands Master Plan; partnerships.

Dr. Barth explained that this workshop would address the planning process involving the existing conditions analysis and the needs and priorities assessment findings. He provided a summary of the recreation trends that indicates a possible need for additional golf courses, swimming pools, multi-purpose trails, fishing and boating access, and additional campsites and athletic fields. He explained that staff visited all of the County's parks and applied 32 criteria to identify if those parks need, met or exceeding expectations and provided a summary of the improvements needed. Next, he provided a brief overview of the operations, programs and maintenance.

Barth summarized the operations, programs, maintenance associated with the County parks as well as the facilities level of service and regional and community parks. Regarding funding, he explained that there may be a need for increased taxes and impact fees. In summary, the needs assessment shows facility priorities as multi-purpose pools, indoor recreation/community swimming centers, additional large community parks and multi-purpose sports fields. The programs priorities include community special events, fitness/wellness, nature and environmental, movies in the park, arts and craft classes, water fitness and camps. A brief discussion followed.

The workshop meeting recessed at 5:48 p.m. and reconvened at 6:01 p.m. into regular session.

RS200608 - 6:02:39 Todd Washecheck, a resident of Clements Road, came forward to voice his concerns regarding the Woodbridge Planned Unit Development (PUD) flooding and his neighbor's properties and neglecting to place the necessary separation fencing. As a result, Woodbridge was sent an ordinance violation from the County seven days ago. addition, Woodbridge PUD's engineer, Daniel McCranie, requested access to his property in order to move his construction equipment. As a result, Mr. Washecheck requested the County issue a cease and desist order to stop further construction work. He also advised that other residents in the area have drainage issues as well as a result of the Woodbridge PUD construction since 1975. Mullin responded that Engineer has been out to the properties and Code Enforcement is actively pursuing remedies for the violation through the process. He offered to meet with Mr. Washecheck later this week to discuss the Code Enforcement process and the other issues he has experienced.

PRESENTATION(S):

RS200608 - 6:31:42 (Tab B) Sean Lahav and Jack Shad, Northeast Florida Regional Council (NFRC), regarding the regional economic effects on Coronavirus Disease 2019 (COVID-19).

Discussion: Mr. Shad telephonically advised that this is a study addressing how the economic shutdown affected Northeast Florida Region. He explained that the study was performed by using the Regional Economic Models, Inc. (REMI).

Mr. Lahav telephonically provided a PowerPoint presentation to address the results of the economic impact study. study predicted a "V-shaped" recession to take place April 2020 through May 2020; however, it would be followed by a rapid recovery to take place May 2020 through June 2020 when restrictions were lifted. Mr. Lahav discussed an overall decline in the Gross Domestic Product (GDP) of 2.7 percent projected across the entire nation and how the economics effects will be different from the nation as a whole resulting in more than 41,000 jobs lost locally with 30,000 of these jobs are out of Duval County. The hardest hit jobs included construction; finance and insurance; real estate and rental and leasing; health care; accommodation and food services; and, other services that are not broken NFRC is working with partners to down into the table. review data and conclusions in order to create strategies on moving forward and is anticipating receiving funding from the federal government to address economic resilient challenges over the next two (2) years for long term recovery. The COVID-19 situation is still evolving.

Discussion: Dr. Barth advised that during his assessment of the property that he identified several concerns with the property including that it is located in jurisdictional wetlands and inquired if it was feasible to create the attractive waterfront experience that local residents were seeking; whether the property was close enough to the existing Kings Ferry boat ramp and with no beach or grassy area the cost to build an attractive well drained multipurpose recreation area with a playground; and, the cost to permit and develop infrastructure for an overflow parking Dr. Barth stated that upon further reflection on what the County is trying to achieve he went back to the original existing Kings Ferry site and noticed that there is a vacant land including an old store that is for sale. He inquired if it would be more feasible to inquire about expanding the Kings Ferry site as a potential alternative in order to create a larger multipurpose site that would meet all of the needs of over flow parking; additional recreation area; and, trail system.

Mr. Mullin advised that during the due diligence period, the title information was received indicating that the neighboring property is a platted subdivision that obtains one (1) lot that encroaches upon the property that is under contract. In addition to that platted subdivision, he advised that it was recorded prior and contains specific restrictions that would require 70 percent of the neighboring owners' approval to change the plat or the conveyance of restrictions to accomplish that. Mr. Mullin raised concerns regarding the dock that was built. He stated that the property owner visited the site with an

environmental consultant and indicated that Department of Environmental Protection (DEP) states that there were no issues. Staff has requested a 90 day extension to address these concerns including the title issues but the property owner countered that they would offer a 45 day extension and for the County to put a deposit of 2.5 percent of the purchase price. He advised that with the concerns that were raised by Dr. Barth, it would require to hire a consultant at the estimated cost of \$25,000.00 to \$30,000.00. Brief discussion followed.
