# Official Agenda Summary:

RS200617 - 9:04:06 Dr. Eugenia Ngo-Seidel, Nassau County Health Department Director, telephonically reported that the County's Coronavirus Disease 2019 (COVID-19) test completion as of June 16, 2020 was 5,378 tests with total positive cases of 94 which include 86 residents and eight non-Florida residents. She explained that the recent rise of positive cases can be affiliated with the recent regulated mandate for long-term care staffing to be tested every two (2) weeks and pre-procedural testing for hospitalization. It is estimated that 15 percent of the positive cases have been asymptomatic. Discussion followed.

RS200617 - 9:09:14 Greg Foster, Emergency Management Director, telephonically provided a COVID-19 update. He advised that the Emergency Operations Center (EOC) continues to support the Department of Health (DOH) logistically and is preparing for the upcoming hurricane season in conjunction with the COVID-19 pandemic. Personal

Protective Equipment (PPE) is continuing to be supplied and received. The EOC is storing the PPE in a long-term storage facility. Director Foster advised that the EOC is meeting with the Duval County Emergency Management to address public and travel safety, transportation, and, security for the upcoming Republican National Convention (RNC). He explained that upon the upcoming hurricane season, the EOC is working in conjunction with the Nassau County School District and the Northeast Florida Regional Council (NEFRC) to safely facilitate local residents into public shelters, if necessary.

The primary product of the assessment is a comprehensive map series showing each flooding type as it relates to various

data that reflect planning and development concerns. Mr. Diamond advised that the County is in receipt of the entire geo-database for future and strategic planning. He provided a brief overview of public workshops that were held for each phase of the project; series of maps in each sequence displayed; flood zones and water occurrence changes; storm surge and sea level rise projections; and, different types of themes evaluated including land use, infrastructure, demographics, housing and buildings, cultural resources, and, special topics (Phase II).

RS200617 - 9:37:17 Expansion Item #1: Presentation by Robert Companion, County Engineer, regarding Thomas Creek.

**Discussion:** Mr. Mullin provided the public comment received from Eric Bowen addressing his concerns with the desnagging project of Thomas Creek. In response, Mr. Companion

advised that staff is working with the U.S. Army Corps of Engineers in the Master Storm Water Drainage studies for a long-term resolution. Katie Peay, Senior Stormwater Engineer, came forward to provide the Thomas Creek Report PowerPoint presentation. She explained that Thomas Creek borders Duval and Nassau Counties, and pointed out that the water shed is extremely unique due to the soil being clay with limited elevation based on the topography. Prior to Federal Emergency Management Agency (FEMA), Thomas Creek had no regulations on the buildings and has no defined base flood elevation (BFE) in this area for development. Peay provided a brief overview of the desnagging efforts. She indicated that the grant funding to clear the debris of roughly six (6) miles of Thomas Creek had expired and no longer eligible for any additional grant funding until a long-term plan is created based on the study being performed jointly by the U.S. Army Corps of Engineers and Nassau County. She advised that the Thomas Creek Planning Assistance to States (PAS) contract was executed September 30, 2019 with the estimated date of completion in the spring of 2021. She provided a brief overview of the PAS; and, scope of services. In conclusion, this study will provide data that will enable the County to work with FEMA to update the floodplain and map designation. After a brief discussion, Mr. Mullin advised that he would research whether a Municipal Services Taxing Unit (MSTU) has been established for Thomas Creek.




