RS200715 - 9:08:30 Dr. Eugenia Ngo-Seidel, Nassau County Health Department Director, telephonically reported that there is an increase of 215 new cases which brings the total to 570, including 548 residents. The number released from isolation as of today is 217 residents with 331 or more in isolation. There was an increase in testing which increased the percent positivity. The Department of Health is continuing to provide testing throughout the County and key messaging is working though Emergency Operations Center.

# PRESENTATION(S):

RS200715 - 9:11:12 (Tab A) Nick Howland, Fire Watch Council Executive Director, and Lynn Schultz, Vice-Chair regarding update on Fire Watch Council.

**Discussion:** Mike Fleming, Chairman of the Fire Watch Council, came forward to provide an overview of the challenge. He introduced Lynn Schultz as the representative for Nassau County.

Ms. Schultz came forward to review the Challenge. stated that veteran suicide numbers range from 20-22 people per day. In 2019, the suicide rate for the State of Florida was 14.5 percent and Nassau County suicide rate was 21.7 percent. She stated that implementation of any type of suicide prevention program will impact the all the rates. She reviewed the structure of the Fire Watch Council stating that it was formed in November 2019 by five counties with contributions of seed funding and a council member. The Fire Watch Council is pursuant to Florida Statutes 163.01, to coordinate regional efforts to reduce military veteran suicides in Northeast Florida. reviewed the strategy to end veteran suicide in Northeast Florida and reinforce the 5-county area as the most military friendly community in the United States.

Mr. Fleming came forward to review the awareness and outreach programs. He mentioned the structure consists of volunteers. He referenced the VA Governor's Challenge which the Fire Watch Council represents Northeast Florida. He referenced Substance Abuse and Mental Health Services Administration (SAMHSA) which offers communities the

opportunity to do a workshop to examine what is happening when a veteran is in crisis. He mentioned that it is important for veterans to know what resources available. The Fire Watch Council has compiled a resource quide for all the resources available to support veterans. Mr. Fleming reviewed the Watch Stander Program which is a peer program designed to connect veterans. The program is not only for veterans but also civilians that can assist. He discussed the wallet cards that are available distributed all across Northeast Florida to veterans in crisis.

Nick Howell came forward to review the Fiscal Year Expenditures for 2020 and the Fiscal Year Funding for 2021. He advised for the Fiscal Year 2021 there will an increase in budget to start launching 2-3 key additional elements which is to increase the Watch Stander Program and Rates. They will also launch a micro grant program which is based upon SAMHSA to assist in directing funding to resources to build up and improve the weaknesses. They will be requesting \$25,000 from Nassau County for the 2021 Fiscal Year.
