➤ Blackmon Road Cross Drain Replacement Project (Jax Utilities Management): Replaced 40 LF of failed storm drain, installed concrete end walls, sodded disturbed areas and constructed asphalt overlay

Paved Road Overlay Program (Level & Overlay):

- Shoulder Prep Road Department Staff Completed
- Overlays Hubbard Construction Began 8/12; Conner Nelson Rd, St Mary's Circle,
 Lessie Rd, Gressman Rd, Robin Rd, Jean Rd, Debbie Rd, Melissa Rd, Barnwell
 Circle, Mt Zion Loop, Mt Zion Ct and Marsh Lakes Intersection all completed.
 Remaining roads to be done by 9/4: Lime St, Geiger Rd, Crews Creek Intersection, Lang Rd
 Intersection and Maranatha Rd Intersection.
- Temporary Striping Road Department Staff Scheduled as needed after each completed overlay
- o Permanent Striping Roadside Specialties Scheduled to begin mid-September
- Shoulder Finish Work Road Department Staff Completed by late September

- Phase 1 Chip Seal Application- Asphalt Paving Systems- Scheduled for week of September 7th

Phase 2 Roads (Mobley Heights Road, Merlin Road, Live Oak Drive, Palm Circle, Mill Creek Road, Maria Avenue & Shirley Avenue)

- Phase 2 Road Prep (drainage & road base) Road Department Staff 10% Completed
- Phase 2 Chip Seal Application Asphalt Paving Systems Scheduled for week of November 16th

Citrona Drive Storm Drain Replacement Project:

o Project began August 5th – DB Civil Construction – 95% Complete; Failed Storm Drain replaced, disturbed areas cleaned up and constructed asphalt patch

Eastwood Drive Outfall Ditch Project:

Project began July 27th – Pars Construction Services LLC – 10% Complete; Layout of the walls verified and sea wall installation (posts) began. Anticipated Completion late October 2020.

Owens Farm Road Cross Drain Replacement Project:

o Project scheduled to begin in September 2020 – Jax Utilities Management – 0% Complete

Sidewalk Repairs Project:

- o Grinding "Uneven" Sidewalk Sections Road Department Staff 98% Completed
 - o Performing this work vs contracting out replacements saved an estimated \$50k
- Replacing Broken Sidewalk Sections (17,000 SF)— Jax Utilities Management —
 <u>0% Complete</u> Project scheduled to begin early September 2020; project awarded at July 27th BOCC meeting
- Replacing Damaged or Missing ADA Mats (195) Jax Utilities Management—
 2% Complete Project started August 24, 2020 on east side of County District 1; project awarded at July 27th BOCC meeting
