Dear Chairman Leeper:

The Department of Economic Opportunity ("Department") has reviewed the proposed comprehensive plan amendment for Nassau County (Amendment No. 20-04ESR) received on September 17, 2020. The review was completed under the expedited state review process. We have no comment on the proposed amendment.

The County should act by choosing to adopt, adopt with changes, or not adopt the proposed amendment. For your assistance, we have enclosed the procedures for adoption and transmittal of the comprehensive plan amendment. In addition, the County is reminded that:

- Section 163.3184(3)(b), F.S., authorizes other reviewing agencies to provide comments directly
 to the County. If the County receives reviewing agency comments and they are not resolved,
 these comments could form the basis for a challenge to the amendment after adoption.
- The second public hearing, which shall be a hearing on whether to adopt one or more comprehensive plan amendments, must be held within 180 days of your receipt of agency comments or the amendment shall be deemed withdrawn unless extended by agreement with notice to the Department and any affected party that provided comment on the amendment pursuant to Section 163.3184(3)(c)1., F.S.
- The adopted amendment must be rendered to the Department. Under Section 163.3184(3)(c)2. and 4., F.S., the amendment effective date is 31 days after the Department notifies the County that the amendment package is complete or, if challenged, until it is found to be in compliance by the Department or the Administration Commission.





Pursuant to Section 163.3184, Florida Statutes, Council review of proposed amendments to local government comprehensive plans is limited to adverse effects on regional resources and facilities identified in the strategic regional policy plan and extra-jurisdictional impacts that would be inconsistent with the comprehensive plan of any affected local government within the region. A written report containing an evaluation of these impacts, pursuant to Section 163.3184, Florida Statutes, is to be provided to the local government and the state land planning agency within 30 calendar days of receipt of the amendment.

DESCRIPTION OF AMENDMENT

The proposed amendment updates the Nassau County Transportation and Capital Improvements Element of the Nassau County Comprehensive Plan and the Future Transportation Map Series. The new text indicates that Nassau County will work with utility companies to establish trails using utility corridors to create a safe, interconnected system for recreation and transportation outside of designated right of ways. In the Future Transportation Map Series, Nassau County will significantly expand bike paths and hiking trails along the county's major roads.

Pursuant to Section 163.3184(3), Florida Statutes, (F.S.) in its role as a reviewing agency as identified in Section 163.3184(1)(c), F.S., the Florida Department of Transportation (FDOT) reviewed the proposed amendment, Nassau County 20-4ESR.

Nassau County has transmitted a text amendment to amend and add policies to the Transportation and Capital Improvements Elements of the County's Comprehensive Plan as well amending the Future Transportation Map Series (FTMS) and updating the data and analysis for the Transportation Element. Among the changes include adding the County's FTMS and the ENCPA Sector Plan Mobility Network to the list of plans to be reviewed for consistency prior to a development's construction plan approval, potentially adopting a sidewalk and trail fee in-lieu of policy for construction of sidewalks and trails, and adding Policy T.02.06 to the Transportation Element which states how roadways are to be designed and operated.

The proposed amendment has no significant impact on important state transportation resources or facilities within its jurisdiction. We appreciate the opportunity to review the proposed comprehensive plan amendment and request that a copy of the adopted amendment, along with the supporting data and analysis be transmitted within ten working days after the second public hearing for FDOT review.
