Analyzes and researches potential and existing operations, systems, services and procedures to determine where necessary improvements are needed. Identifies and/or proposes programs, policies, directives to determine feasibility or impact on agency, establishes guidelines and time frames for analysis of programs, operations or procedures; monitors work product and may provide technical assistance to team/unit members. Implements solutions to problems and assists in and/or develops new systems, policies or programs to increase agency efficiency and effectiveness.

MAJOR JOB DUTIES:

- Works with Operations Executive Management to develop priorities, research projects, and training needs.
