County, and there exists a need to extend this local State of Emergency to facilitate measures to protect

citizens, visitors and property.

County, Florida, this 14th day of December, 2020 as follows:

Local Emergency for an additional seven-day period from December 14, 2020 through December 21,

2020 due to on-going situations associated with COVID-19 in areas within the county.
