Nassau County Emergency Management, in cooperation with the Florida Department of Health in Nassau County, have developed a plan and process for the distribution of COVID 19 vaccinations. The following information provides the step-by-step process for individuals to;

- Register for the opportunity to make an appointment for vaccination,
- Reserve a time and date for the vaccination, and
- Obtain further information on the vaccination process.





Register for the opportunity to make an appointment for vaccination

- Individuals who are within the targeted group (age or occupation) will be asked to visit the Nassau County Emergency Management website (onenassau.com) and follow a link to the Eventbright page.
- Individuals who follow the link to Eventbright will be asked to provide appropriate information and will be provided with a virtual ticket indicating that they will be able to call into the Nassau County Emergency Management Citizens Information Center (CIC) to secure an appointment for vaccination.
- It is requested that only individuals who are part of the target group preform the above process and that they continue through the entire process to avoid having available vaccine, and times and dates to obtain vaccination, which are not utilized.



Reserve a time and date for the vaccination

- Once the individual obtains a "ticket", they will be provided with the information to call into the NCEM Citizens Information Center to reserve a time and date to have the vaccination administered.
- The individual will be provided with all of the appropriate information on location, time, date, and needed information to complete the process during the vaccination.
- Again, it is very important that individuals who make an appointment to be vaccination complete the entire process to ensure that all of the available vaccine is utilized in the safest and most efficient manner.
- Information on the second vaccine in the current two vaccine protocol will be provided by the FDOH – Nassau.

Obtain further information on the vaccination process

- The Nassau County Emergency Management Citizens Information Center is being staffed with NCEM Staff, Nassau County Sheriff's Office personnel, and Volunteers affiliated with the Emergency Operations Center.
- Individuals who call into the Citizens Information Center can perform the following tasks;
- Obtain general information on the vaccination process,
- Obtain assistance in registering for the opportunity to make an appointment,
- Obtain the time and date for the vaccination once they have registered,
- Obtain follow up information and further guidance and safety information on COVID 19.





Public Information, Social Media, and Press Releases

- Information provided to the public as it relates to COVID 19 vaccinations will be released through the OneNassau, onenassau.com and #onenassau platforms.
- The purpose of this process is to ensure that a consistent, accurate, and singular message is provided to reduce confusion and avoid ineffective messaging.
- In addition to the onenassau platform, everbridge, nixel, and next door applications will be used to provide information on additional vaccination opportunities, up to date information on vaccine questions, and continuing COVID 19 information.
- Press releases will continue to be provided through the Nassau County Emergency Management Joint Information Center, which will be coordinated by the NCEM Public Information Officer.
