RS210125 - 6:07:59 (Tab E) Consider a Resolution of the Board of County Commissioners of Nassau County, Florida, relating to the South Amelia Island Shore Stabilization Municipal Services Benefit Unit and the funding construction of a beach renourishment local improvement; declaring that the project costs of said local improvement shall be paid by special assessments levied against real property specially benefited by said local improvement; describing the assessment area and subareas therein; determining the estimated total project cost of the beach renourishment local improvement; establishing the terms and conditions of proposed special assessments to fund the proposed special assessments to fund the project cost of the beach renourishment local improvement; providing for collection of the special assessments pursuant to the Uniform Method Collection; establishing a public of hearing; authorizing and directing mailing and publication of notice of the public hearing; and providing an effective date.

Discussion: Mr. Mullin stated that the purpose of the proposed Resolution is to schedule a public hearing that would be held on April 12, 2021 at 6:00 p.m., or as soon thereafter as the matter may be heard. Individuals can address the Resolution and funding of the project at that time. He explained that each property owner that is subject to the assessment will receive notification of the public hearing and it would be published in the newspaper. Mr. Mullin addressed the permit application that has been South Amelia Island Stabilization submitted by Shore Association (SAISSA). He stated that any property owner that did not receive the notification regarding the public

hearing may contact either the County Manager Office or County Attorney Office for a copy of the notice.

Public Input:

- Drew Wallace, President of Olsen Associates, Inc., came forward to advise that he was available to answer any questions. He responded to an inquiry that the last beach renourishment took place ten years ago and that this beach renourishment would be the fourth. He addressed the difference in this permit versus the prior three permits. He clarified that the beach renourishment would only be necessary when the beach sand reaches a certain diminished level. Mr. Wallace provided a brief history of the timeframe of the prior beach renourishments.
- Browder, Principle Engineer • Albert Associates, Inc., came forward to address the past cycles of renourishment efforts. He advised that if Florida Department of Environmental Protection (FDEP) approves the permit it would be a one-time permit effective for 15 years. This permit contains condition that only one nourishment element will be allotted with the requirement of being monitored and submittal for review to complete the beach renourishment. He noted that there is the ability to apply for a major modification to that permit down the road if needed.
- Dr. Christopher Cates, SAISSA Board Member, came forward to speak in opposition. He provided his professional background. Dr. Cates expressed concerns that SAISSA consultants would greatly benefit financially if the capital assessment was approved. He also addressed his concerns with irregularities as it relates to the beach renourishment process.
- William Moore, SAISSA Project Manager, came forward stating that tonight's meeting is to schedule a public hearing and he would provide rebuttal to Dr. Cates' comments at that time.

Discussion: Greg Foster, Emergency Management Director, provided a brief update regarding the vaccination process for COVID-19. He stated that by 5:00 p.m. on January 26, 2021, 975 citizens will have been vaccinated. The next allotted 975 vaccinations scheduling started today with a quarter of the appointments currently filled. He anticipates vaccinations to begin on January 27, 2021. Discussion followed.

Dr. Eugenia Ngo-Seidel, Nassau County Health Department, appeared via "Zoom" to provide a health update related to COVID-19 pandemic. As of January 25, 2021, Nassau County had a case count of 6,682 of which 6,296 are residents and 386 are non-residents. There have been 394 new cases since

the previous week and currently 1,097 active resident cases. The percent positivity for the past week decreased from 15.7 percent to 14.6 percent. The next mobile testing event will be held on January 26, 2021, at the First Baptist Church of Fernandina Beach from 3:30 p.m. to 5:00 p.m. and January 28, 2021, at the Journey Church in Yulee from 9:30 a.m. to 11:00 a.m. She stated that 7,040 residents have received their first dose of vaccine and 569 residents have completed their second series of vaccinations.

Discussion: Dr. Barth appeared via "Zoom" to provide a PowerPoint presentation outlining the Parks, Recreation,

and Open Space Master Plan. He explained the purpose of the plan. He reviewed the processes; (1) Needs Assessment Findings - top priorities for activities/programs, top priorities for amenities, needs assessment priorities. (2) Long-Range Vision - no standards, vision framework, department mission, guiding principles, classifications, regional parks, community parks, (3) Preliminary Implementation subsystems. Strategy funding, top priority needs, and implementation strategies besides capital improvements.

Mr. Pope explained that the Parks, Recreation, and Open Space Master Plan will be divided into short term goals and strategies with the overall implementation to take place over decades. He stated that there are specific actions in the Resolution that allows staff 180 days to bring back to the Board an update to the Comprehensive Plan and Land Development Code (LDC). He pointed out that the previous board approved funds to be placed in the budget to hire a new Parks and Recreation Director. Mr. Pope responded to an inquiry stating that he does not know the salary for the new director, but the Public Works Director has already conducted the first round of interviews with the second round of interviews to be held next week. Discussion followed.

Noted: County Manager to bring back to the Board the salary for the new director and also research at what point other counties in the State of Florida hire a director and whether it is based upon population.

Discussion: Thad Crowe, Planning Director, came forward to provide a PowerPoint presentation. He provided an overview of the timeline of the project. He advised that the CLAM Program is grounded into the Vision 2032, Comprehensive, and Western Nassau Heritage Preservation Vision Plans. These plans will provide natural habitat protection; passive parks, open space; and publically accessible conservation lands. He noted that these plans work together with the goal to improve the quality of life and so many other things that would benefit Nassau County.

Rebecca Perry, North Florida Land Trust (NFLT) Director of Real Estate and Community Conservation, appeared via "Zoom" to provide an overview of the CLAM Program PowerPoint presentation. Ms. Perry provided а brief background regarding NFLT. She addressed the process for creating a CLAM Committee, as well as the Committee's responsibilities. Ms. Perry provided an overview of the application process to nominate land; negotiations; final review process by the CLAM Committee. She explained that once the acquisition is approved by the Board of County Commissioners additional due diligence would still be obtained to ensure that it meets the needs of the County. She provided a brief overview of the finalization of the acquisition and management plan for each property.

Mr. Pope responded to an inquiry that it will take a full year before the CLAM Committee would start negotiating properties. He stated that if the CLAM Program Ordinance is approved, NFLT and County staff will work on advertisement and seeking applications. He recommended a window of 30 days for applications to be submitted and to bring back to the Board. He felt that a CLAM Committee could be formed within 60 days.

Next, Ms. Perry addressed the conservation ranking tool, which is where the CLAM score will come from. It will help the County decide where to apply funding. She explained that there was a foundational document review where all the different County plans were reviewed to assess what was already stated as being important. In addition, NFLT researched various environmental issues and opportunities within the County and developed categories that include the four data layers: water issues; working lands; species and habitat protection; and outdoor recreation/quality of life. Ms. Perry stated that the previous Board was requested to rank and score each resource category and data layers to determine what was most important to them. Ms. Perry briefly commented on the Subject Matter Experts and Public Polling. She provided a brief overview of the CLAM Resource Ranking Map which displays the data layers of the final ranking of the natural resources within Nassau County. She noted that the ranking map was available to the public on the Nassau County Property Appraiser website. She reviews the property score calculator.

Public Input:

- Chadd Charland came forward to speak in support of the adoption and implementation of the CLAM program. He stressed the importance for Nassau County to increase protected land for conservation and improving quality of life.
- Margaret Kirkland, Amelia Island Tree Conservancy, appeared via "Zoom" and thanking the Board of County Commissioners, staff and NFLT for the CLAM Program Resolution. She advised that the Amelia Island Tree Conservancy is available to assist with supporting the CLAM Program.
