Public input: Chad Shaw came forward to express his appreciation for the American Beach Initiative.

Rebecca Perry, North Florida Land Trust, came forward to thank the Board for their work on conservation at American Beach. She is here in support of the American Beach Cultural Heritage Experience Enhancement Initiative. She responded to an inquiry regarding the Nana Dune lots.

**Discussion:** Mr. Pope came forward and provide a brief overview of the January 11, 2021 Board of County Commissioner Workshop which discussed the roles and responsibilities related to the management of the Tourist Development Tax (TDT) Fund. The County Attorney reviewed "frequently asked questions" and legal framework for how the Tourist Development Council(TDC) and Tourist Development Funds are managed. The next step will be an update to the Board of County Commissioners Purchasing, Procurement, and Financial Policies which will include a subset management of the Tourist Development Tax Fund. He commented that the three priority tourism projects are interrelated, synergetic, and compounding. In order to execute there will need to be a comprehensive strategy and will require significant resources which will impact the work programs and budgeting for the next decade. Mr. Pope stated that there will be a budget and planning process.

Mr. Pope discussed the Amelia Island Florida Environmental Branding Initiative. He stated that as part of the Fiscal Year 2020-2021 budget the Board allocated \$350,000.00 of the Tourist Development Tax funds at the recommendation of the TDC towards the implementation of the first phase of the branding initiative. He reviewed staff's direction.

Mr. Pope responded to inquires related to whether there would be additional funding besides the \$350,000.00 already allocated, the first year budget, and grant opportunities. Discussion followed.

He stated that the beaches of Amelia Island are the primary attraction that draw tourist from across the globe. Mr. Mullin stated that the only funds to be used for the three initiatives is the \$350,000.00 already allocated unless the TDC needs additional funds. The tourist have expectations. The perspective change that Nassau County needs is to view the ocean front parks and the beach accesses as gateways to this amenity. In order to meet visitor expectations, enhance visitor experiences and grow the market with return visits the beach gateways needs to match the standard of the natural feature that they access. He reviewed the

staff's direction. The group had further discussion regarding Legal side, funding, implementation strategy, and master plan.

## Amelia Island Florida Environmental Branding Initiative: Staff Direction

1. For the funds allocated in fy20/21 to execute 'Phase 1':

- Prioritize implementing solutions at strategic gateways and key motorist decision points, i.e. round-a-bouts.
- Direct the AICVB, through the AITDC, to bring forward updated cost estimates, funding source, and recommendations for specific improvements to be implemented in Phase 1 for the BOCC to consider.
- 2. Through the AICVB and AITDC, direct staff to expand the contract with Dawson and Associates to identify potential environmental branding solutions for the following corridors/areas based on typical visitor trip patterns, key motorist and pedestrian decision points, and other orientation factors that impact wayfinding and destination identification on Amelia Island.
  - 14th Street
  - A1A on Amelia Island
  - SR200/A1A from CR107 to the Amelia Island Parkway
  - Amelia Island Parkway segment not part of A1A
  - Sadler Road
  - · Strategic public spaces/lands along identified corridors
  - Intersections of AIP and Fletcher Ave./Julia St. and First Coast Hwy
- 3. As part of the expanded contract, Dawson and Associates are to deliver a comprehensive menu of environmental branding solutions with cost estimates, funding source, annual maintenance cost estimates, and an implementation schedule that corresponds with the 10-year planning horizon.
- 4. Target completion by July 2021 in order to provide inputs for 21/22 annual budget and 5-yr CIP (21/22 26/27).
- 5. In coordination with the AICVB, direct OMB to calculate a preliminary estimate for use in fy21/22 budget development and the corresponding 5-yr CIP. Cost will be refined as the related directives are executed.

Project Notes: (1) AICVB will provide project management and oversight (2) Services by Dawson and Associates are to paid for with Tourist Development Tax dollars, subject to review by County Attorney/OMB Director/Procurement Manager





Amelia Island Beach Front Parks Branding Harmonization & Visitor Experience Enhancement Initiative: Staff Direction

- Direct the AICVB, through the AITDC, to create and bring back to the BOCC for consideration, a scope of work to execute a study and create an implementation strategy that:
  - Harmonizes environmental branding amongst all beach front parks and beach access points
  - Enhances visitor experience at all beach front parks and beach access points
- 2. The scope shall include, at a minimum:
  - Conceptual enhancement plans/packages for the following seven beach front parks:
    - (1) Main Beach Park, (2) Sadler Seaside Park, (3) Peters Point Park, (4) Burney Park, (5) Scott Road Access, (6) Southend Access, (7) North Beach Park Access
  - Corresponding and comprehensive menu of visitor enhancements projects/packages with cost estimates, funding sources, annual maintenance cost estimates, and a recommended 10-year implementation strategy.
  - Incorporation of the work executed by Dawson and Associates as part of the Amelia Island Florida Environmental Branding Initiative.
- In coordination with the AICVB, direct OMB to calculate a preliminary estimate for use in fy21/22 budget development and 5-yr CIP. Cost will be refined as the related directives are executed.

Project Notes:

- 1. AICVB will provide project management and oversight
- 2. Tourist Development Tax dollars to fund execution of the study and creation of an implementation strategy, subject to review by County Attorney/OMB Director/Procurement Manager

#### American Beach Cultural Heritage Visitor Experience Enhancement Initiative: Staff Direction

- 1. Based on the 2/16/21 Outline project plan, scope of work and timeline:
  - i. Direct staff to work with Dr. David Barth to finalize the project scope
  - ii. Work with County Attorney, OMB Director and Procurement Manager to secure services via the proper mechanism at an amount not-to-exceed (NTE) \$175,000
  - iii. After receiving AITDC input related to scope of service, bring back to the BOCC for consideration the final scope of service and contract/work authorization to execute the assignment.
  - iv. Target completion Q-4 2021.
- 2. In coordination with the AICVB, direct OMB to calculate a preliminary estimate for use in fy21/22 budget development and corresponding 5-yr CIP. Cost will be refined as the project progresses.

#### Project Notes:

- 1. Nassau County's Planning and Economic Opportunity Dept. will provide project management and oversight
- 2. The project team has been identified and is listed in the outline project plan
- 3. Study funding will be from a combination of:
  - PEO's current budget for planning activities in American Beach (\$30,000)
  - Recreation Impact Fees for aspects related to increasing recreation capacity (\$17,500 +/-)
  - Tourist Development Tax fund (\$127,500 +/-)
