

**RESOLUTION NO. 2010-161****A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, DESIGNATING A COUNTY-WIDE ARTS COUNCIL**

**WHEREAS**, the Board of County Commissioners of Nassau County, Florida, recognizes the importance of the arts in enriching the lives of our citizens and in attracting tourism, new residents, and new business to Nassau County, and in the development of our youth through arts education; and

**WHEREAS**, the Board of County Commissioners of Nassau County, recognizes the Fernandina Beach Arts Council as acting in the interests of all residents of Nassau County as the designated local arts agency; and

**WHEREAS**, an Arts Council recognized by the State will benefit arts in the community from a grant and other funding opportunities; and

**WHEREAS**, the City of Fernandina Beach has adopted Resolution No. 2007-102, which created an Arts Council to improve the appreciation, awareness and cultural opportunities of all the arts in the community by promoting and enhancing the arts; and

**WHEREAS**, City of Fernandina Beach Resolution No. 2007-102 created an Arts Council in order to provide a focal point through one group to represent the arts community county wide.

**NOW, THEREFORE BE IT RESOLVED** by the Board of County Commissioners of Nassau County, Florida, as follows:

1. The Board of County Commissioners of Nassau County, Florida, hereby supports the designation of the Fernandina Beach Arts Council as the County-wide Arts Council.
2. The Board offers its endorsement of the Fernandina Beach Arts Council in seeking technical support from the State of Florida Arts Council and grant



support from the National Endowment for the Arts and the pursuit of any other grant opportunities to finance art related programming, facilities or awareness.

3. The County Manager shall annually review a report compiled by the Arts Council which shall contain financial information and activities conducted that demonstrate that the Arts Council has a county wide focus and that the arts council has promoted and continues to promote awareness, appreciation, enjoyment and enhancement of arts programs and facilities.
4. The designation of the Fernandina Beach Arts Council as the County-wide Arts Council shall be revoked if, in the exclusive judgment of the Board of County Commissioners, the Arts Council ceases to have a County-wide focus.



**RESOLUTION NO. 2011- 123**

**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF  
NASSAU COUNTY, FLORIDA, AMENDING RESOLUTION NO. 2010-  
161, WHICH DESIGNATED A COUNTY-WIDE ARTS COUNCIL,  
RENAMING THE ARTS COUNCIL TO BE KNOWN AS "ARTS AND  
CULTURE NASSAU"**

**WHEREAS**, the Board of County Commissioners of Nassau County, Florida adopted Resolution No. 2010-161 on October 25, 2010, which supported the designation of the Fernandina Beach Arts Council as the County-wide Arts Council; and

**WHEREAS**, the Arts Council has changed its name to Arts and Culture Nassau;  
and

**WHEREAS**, the Board of County Commissioners supports the renaming of the Fernandina Beach Arts Council as the Arts and Culture Nassau; and

**WHEREAS**, the City of Fernandina Beach adopted Resolution No. 2011-70 in support of the renaming of the Arts Council.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of Nassau County, Florida as follows:

1. The Board of County Commissioners hereby supports the renaming of the Fernandina Beach Arts Council to *Arts and Culture Nassau*.
2. The Board of County Commissioners further restates its intent that the *Arts and Culture Nassau* shall act as the designated county-wide local arts agent, as renamed.
3. The Board of County Commissioners further restates its intent that the designation of the *Arts and Culture Nassau* as the county-wide arts agent shall be revoked if, in the exclusive judgment of the Board of County
