CLOSED SESSION 11:00 a.m.:

EC211006 - 11:01:44 (Tab C): Mr. Mullin explained that the meeting would commence as an open session at 11:00 a.m. and a request will be made to close the meeting in order to discuss several aspects and review the documents to the Board Members relating to the beach. The first document he referred to was Florida Statutes, Chapter 161.58, which are the general laws that govern vehicular traffic on coastal beaches. In paragraph three, once vehicular traffic is permitted on the beach, it can only be removed by a certain vote of the governing body.

Mr. Mullin referred to the next document, Senate Bill 1577 (SB1577), noting that this Special Act of the Legislature controls vehicular parking and driving on Nassau County beaches. This bill came about at that time when the Board of County Commissioners had conducted a study to determine how much off-beach parking was available. A The indicated that there was not adequate off-beach parking available to handle a certain percentage of beach traffic and the Board's determination was to continue to drive on the beach. The development community felt that the study they challenged it in flawed and court interpretation. He explained that the Board's concern was if the development community was successful, beach driving would be eliminated. The Board of County Commissioners decided to participate and ask Legislature for a Special

Act in conjunction with the development community which provided for parking and driving on certain areas of the beach. Shortly after there was a court case filed because the County Commission's and the development community's interpretation of the bill were different. Following the hearing, the Final Judgement was amended confirmed SB1577 by restating the areas where vehicles can drive and park on the beach. He specified that a clause was added indicating that any portion of the south end of Amelia Island which is owned by the State would be restricted for 24 hours. On an accompanying map, Mr. Mullin detailed where vehicles could drive and park on the beach as specified in SB1577.

Next, Mr. Mullin referred to Nassau County's Customary Use Ordinance 2020-18, advising that this Ordinance was developed to preserve the customary uses of the beach. He specified that most of those customary use areas are seaward of the erosion control line. Mr. Mullin referred to the next document which is the County's amended Ordinance 2020-31, which restates the utilization of the beach, including times and restrictions for night driving; and the consideration of endangered turtles. He pointed out that this Ordinance also specifies that driving is controlled by the Florida Statutes, Chapter 161.58, SB1577, and the Final Judgement dated 1992.

Mr. Mullin advised that a recent case was filed by Ameliatel (Ritz Carlton) versus Nassau County. He will provide further discussion regarding the litigation strategy and settlement issues during the closed session.

Mr. Mullin explained that the meeting would be an executive closed session pursuant to Florida Statutes, 286.011(8), to discuss settlement negotiations litigation strategy related to the litigation expenditures in the case of Ameliatel, LP versus Nassau County, Case No. 2021-CA-0173. This meeting is being held at Mr. Mullin's request to advise the Board concerning this matter and seek their advisement. The persons attending will be John Martin, Klynt Farmer, Aaron C. Bell, Jeff Gray, and Thomas Ford, collectively known as the Board of County Commissioners; Michael S. Mullin, County Attorney; Denise May, Assistant County Attorney; Taco Pope, County Manager; and a Court Reporter with Cashman Enterprises, Inc.
