

RESOLUTIONS FOR AUGUST



At the Wednesday, August 3, 2022 meeting, the Board of County Commissioners approved Resolution No. 2022-152, proclaiming the week of July 30-August 6, 2022, as "Gullah Geechee Nation Appreciation Week."

Gullah Geechee Nation Appreciation Week began in 2012 and is meant to celebrate the living legacy of Gullah/Geechee history, heritage, and culture of the Gullah/Geechee people. Their extensive history in Nassau County includes both the enslavement and self-determination of the Gullah/Geechee

people through the history of Amelia Island, Old Town, Yulee, Nassauville, Franklintown, and American Beach.

Queen Quet, Chieftess of the Gullah/Geechee Nation, accepted the Resolution. Several individuals attended as well, representing local families who are descendants of the Gullah/Geechees including the Wood family of Nassauville; the Hooper family of Nassauville; the Thomas family of Yulee; the Blue family of Fernandina Beach; the Albertie family of Nassauville; and the Morris and Simmons families of O'Neil.





PUBLIC HEARINGS

Did you know that there are two types of public hearings: non-quasi-judicial (legislative) & quasi-judicial (administrative)?

Legislative hearings are conducted to formulate and establish county policy for future application, and quasi-judicial hearings apply those adopted policies to factual situations. Quasi-judicial hearings are less formal than actual court proceedings but include similar procedures, such as ex-parte disclosure, acceptance of documents into the record, and the finding of competent substantial evidence. Ultimately, the policies adopted during legislative hearings construct the framework for which decisions are made during quasi-judicial hearings.

During the August 29, 2022, Nassau County Board of County Commissioners meeting, a legislative hearing was held to consider an ordinance allowing for the expenditure of funds for refreshments at countysponsored events; the hearing was legislative because it considered adopting a new policy. During that same meeting, two quasi-judicial hearings were held to consider approval of a Final Development Plan and a Rezoning Application, both of which required consistency with criteria outlined in the Comprehensive Plan and the Land Development Code, and the final decision to approve both applications relied upon competent substantial evidence in the record and testimony received during the hearing.

Not all boards and committees hold public hearings; some simply act as advisory boards that make recommendations to the Board of County Commissioners; however, the Planning and Zoning Board, Code Enforcement Board, Conditional Use and Variance Board, and the Construction Board of Adjustments and Appeals hold public hearings regularly. Nassau County citizens are strongly encouraged to attend the public meetings; after all, public meetings are held specifically for the general public to provide input on proposed issues or actions.







Thomas Creek Study

Flooding along Thomas Creek has been an area of concerns for many years. Previous efforts to mitigate flooding with structural components, drainage system maintenance, and snag and clearing have been futile. In November 2017, a meeting was held between representatives of the Army Corps of Engineers, Senator Aaron Bean's Office, State Representative Cord Byrd, and various County staff to discuss other possible solutions. It was discovered at that time that there are programs available under the Army Corps of Engineers' Continuing Authority Program (CAP). Subsequently, the Board sent a letter to the Army Corps of Engineers requesting an investigation of the problems under the authority of Section 205 of the Flood Control Act of 1948. The letter was signed at the December 11, 2017, Board of County Commissioner's meeting.

In April 2018, the County was notified that the project would exceed the limitation of the CAP Program and was recommended to seek a Planning Assistance to States (PAS) Study to help the County identify solutions to resolve the flooding issues. The study began in 2019. It entailed extensive modeling with multiple scenarios considered. The Board of County Commissioners approved the final report in June of 2022 with a directive to staff for an Implementation Plan to be presented in six months.

Part of the Implementation Plan includes community involvement. As such, Engineering staff hosted a community meeting the evening of Friday, August 5th to discuss the results of the (PAS) Study and to determine interest in the different types of grant opportunities (buyout or modification of structures).

Many in attendance questioned why the County isn't dredging Thomas Creek. To do so would require a permit from the Army Corps of Engineers and at this time, the Army Corps has NOT granted approval. This was discussed in great detail during a presentation made by Senior Stormwater Engineer, Katie Peay. The presentation can be found at https://bit.ly/ThomasCreekStudy.

"Dredging did not lower flood waters out of ANY structures. The biggest impact of 8 inches was never in someone's home. This was mostly wetland areas or the Duval side. We are still looking at options with the Army Corps. Nassau County did install a rain gage and sensor on the Creek to continue to truth the model with actual rain events. Engineering staff was very pleased with the community turnout and looks forward to working closely with the residents as we move forward. Multiple homeowners offered to walk with Engineering staff to review areas with debris and blockages including the stagnation around the railroad bridge and beaver dams.

The mission of the Horticulture Extension Agent is to provide science-based horticulture recommendations for residents, green-industry professionals, planners, designers, and communities through educational resources, trainings, and outreach programs.

Success Story:

Gardening is an activity for healing. Recently, after completing a gardening program, a local Nassau County resident began speaking with the horticulture agent about their personal healing from gardening and gardening-related activities as result of attending horticulture extension programming. This specific individual spoke about their daily battles with anxiety and depression. Gardening became a positive outlet for this individual, helping manage their sickness in a beneficial and positive way. Therapeutic Gardening is the formal gardenbased therapeutic sessions with licensed practitioners, but anyone can directly benefit from their personal experiences with gardening. Our horticulture program impacts usually relate to environmental and economic impacts - but gardening is a powerful tool for ourselves and our community.

4-H Youth Development
