The staff report for this agenda item included the following statement:

The applicants are requesting the rezoning of approximately 16.84 acres from Commercial General (CG) to Open Rural (OR). These seven parcels were mistakenly included in the legal description of Ordinance 87-7 that rezoned adjacent property to CG in 1986.

The staff report also stated that "the rezoning is necessary to correct the erroneous rezoning of these properties to Commercial General in 1986."

Staff retracts these statements as they are incorrect in the use of the words "mistakenly" and "erroneously." According to the staff report of August 5, 1986, it was the Planning Commission recommendation and the Board of County Commission's decision to rezone this area to encompass existing commercial uses on the properties thereby bringing those commercial uses into a conformance. The colored map presented to the Board of County Commissioners on August 26, 1986 and passed as attached to Ordinance 87-7 appears to encompass the properties presented in this application for rezoning.
