### FIRST AMENDMENT TO CONTRACT FOR GRAPHIC DESIGN SERVICES

THIS FIRST AMENDMENT TO THE CONTRACT FOR GRAPHIC DESIGN SERVICES (hereinafter "Amendment") is made by and between the Board of County Commissioners of Nassau County, Florida, a political subdivision of the State of Florida (hereinafter the "County"), and My Agency Savannah, LLC, a business having its primary business location at 1 Southern Oaks Court, Suite100, Savannah GA 31405 (hereinafter the "Vendor").

### WITNESSETH:

**WHEREAS**, the Parties previously entered into a Contract for Graphic Design services dated February 3, 2023 (hereinafter "Contract"); and

WHEREAS, the Parties now desire to amend the Contract terms and conditions subject to the provisions contained herein.

**NOW**, **THEREFORE**, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, the Parties do agree to amend the Contract as follows:

**SECTION 1.** The 2022-23 My Agency Estimate Savannah, LLC attached as Exhibit "A" to the original Contract shall be rescinded and replaced with the Amelia Island Scope of Work FY 2024 attached as Exhibit "A" hereto.

**SECTION 2.** Article 4 of the Contract is hereby amended to extend the term of the Contract for an additional one (1) year and the Contract shall now terminate on September 30, 2024.

**SECTION 3** Article 5 of the Contract is hereby amended to increase the compensation amount by Forty-Three Thousand, Six Hundred and 00/100 dollars (\$43,600.00). The Vendor's pricing is included in the Amelia Island Scope of Work FY 2024 attached hereto as Exhibit "A" for the goods/services to be provided under the Contract, and the County shall now compensate the Vendor in an amount not to exceed Ninety-Three Thousand, Four Hundred and 00/100 dollars (\$93,400.00).

**SECTION 4.** All other terms and conditions of the Contract not inconsistent with the provisions of this Amendment shall remain the same and in full force and effect.
