### NASSAU LEGISLATIVE DELEGATION HELD

Senator Clay Yarborough and State Representative Dean Black listened as representatives from the County, City of Fernandina Beach, Town of Hilliard, Nassau County School Board and several non-profit organizations explained their funding needs ahead of the upcoming Legislative Session. Several individuals also spoke about Legislation they wish to see amended and/or introduced in support of various causes and issues important to them.

## **CAPITAL IMPROVEMENT UPDATE**

At the Monday, October 23, 2023 meeting, Deputy County Manager/County Engineer, Robert Companion, provided an update on Capital Improvement Plan (CIP) Projects. The County's CIP is updated annually during the budget process and provides a proactive approach in planning for infrastructure needs such as roadways, facilities and parks. Not only does it identify projects and funding sources, it also provides a project schedule.



The County's current Five-Year CIP includes \$159 million in projects that are currently funded. Of those, \$37 million in projects are currently underway with an additional \$48 million in projects anticipated to begin within the next 6 months.

The CIP also includes \$7.45 million in chip seal projects and another \$24.36 million in Pavement Management projects. Chip seal is an alterative surface treatment used to create an asphalt layer and is often used on lower traffic volume roads. Pavement Management funds are used to improve/repair existing paved roads and increase their lifecycle.

#### **EMPLOYEE RECOGNIZED FOR YEARS OF SERVICE**

At the Wednesday, October 18th meeting, the Board of County Commissioners recognized John Wayne Williams for 30 years of service to Nassau County.

John Wayne began his employment with Nassau County on October 8, 1993 as a Maintenance Helper in the Road Department. Over the years, John Wayne has proven himself to be a value

member of the organization and has served in several other capacities including as a Truck Driver, an Equipment Operator, and most recently, as a Foreman where he has spent the last seven years performing supervisory work and participating in the maintenance and construction of roads and bridges. He also oversees work crews, equipment operators, and truck drivers who participate in the construction, maintenance and repairs of roads and bridges, and associated road structure. In this position, John Wayne also serves on the on-call rotation for after work hour emergencies.



#### **NEW HEALTH DIRECTOR SELECTED**

Kerry Waldron with the Florida Department of Health attended the October 23, 2023 Board of County Commissioner's meeting to introduce Ms. Cara Gluck as the new Administrator of the Nassau County Department of Health. He stated, "We think we have a great candidate for Nassau County. She comes with 20+ years of experience, ranging from local, statewide and regional management positions and has a strong background in emergency management and planning. Ms. Gluck also has a Masters Degree in Public Health."

Though the Florida Department of Health interviews and selects the person for this position, Florida Statutes, Section 154.04(b), requires that the Board of County Commissioners provide concurrence on the position. The Board approved the appointment with a 5-0 vote. She will begin as the new Administrator in early 2024.

"I am excited about this opportunity and to working with you to ensure we're providing the best services from a public health perspective for all of the residents," stated Ms. Gluck.

The Board looks forward to working with Ms. Gluck and supporting her in her new role as Administrator of the Nassau County Department of Health.



## **PROCLAMATIONS ISSUED**

At the Wednesday, October 18th meeting, the Board of County Commissioners approved Proclamation 2023-002 declaring the month of October 2023 as "Emily Adkins Blood Clot Awareness Month." The Proclamation was requested by the family of the late Emily Adkins, a young lady who lost her life to a blood clot in October 2022 at the age of 23. She is the daughter of residents Doug Adkins and Nassau County Supervisor of Elections Janet Adkins.

According to the National Blood Clot Alliance, an estimated 900,000 individuals in the United States are affected and 100,000 are killed by preventable blood clots annually. Blood clots can affect any individual at any age through various risk factors, such as surgery, pregnancy, and cancer treatment, killing more Americans than car crashes, AIDS and breast cancer combined.

After Emily's passing, the family established Emily's Promise, a not-for-profit organization dedicated to raising awareness of blood clots, pulmonary embolisms and ankle fracture, as well as promoting kindness as a community value. Emily herself was known to be an exceptional young woman who always expressed kindness toward others and exhibited tremendous compassion for those around her. Unfortunately, Emily's life was cut short by a blood clot after receiving treatment for a broken ankle and gall bladder surgery.

Advocacy efforts by Emily's Promise following Emily's death led to the formal enactment of the Emily Adkins Prevention Act which now requires establishment of a policy workgroup by the Secretary of the Agency for Health Care Administration, in conjunction with the State Surgeon General, to enhance the detection of blood clots in Florida.

What can you do, you ask? Mr. Adkins stated, "The first thing you can do it to check your Caprini risk score to see if you're at high risk for blood clots. If you are having surgery, be sure to ask "what's my blood clot prevention plan." If you start to have symptoms of a blood clot, I would urge you to go immediately to Memorial Hospital who has implemented a mechanical thrombectomy so when they identify a clot, they will actually remove it and not just send you home with anticoagulants attempting to reduce the clot."

## **COUNTY AWARDED RECYCLING GRANT**



The U.S. Environmental Protection Agency recently announced more than \$1,173,004 from President Biden's Investing in America agenda to expand recycling infrastructure and waste management systems across the State of Florida. We are excited to report that Nassau County has been awarded a Solid Waste Infrastructure for Recycling Communities Grant totaling approximately \$500,000 to be used for improving its recycling program.

This award will allow the County to optimize the intake and outtake process at the Convenience Recycle Center in Callahan, as well as its recycling site located in Yulee. The County will also increase, expand, or optimize collection

and improve materials management infrastructure to ensure customers deposit recyclables in the correct bin. All of these actions will increase capacity at recycling facilities, reduce container overflow and minimizing incorrect disposal.

"The Board of County Commissioners recognizes the importance of recycling and reducing the amount of waste being sent to the landfill. Like many growing counties, we continue to search for ways to improve recycling through educating residents and offering recycling opportunities throughout the County," said Chairman Klynt Farmer. "We are proud to be selected for the Solid Waste Infrastructure for Recycling Grant and look forward to leveraging those funds to improve Nassau County's recycling program for the betterment of the environment and our residents."

The Solid Waste Infrastructure for Recycling Communities Grant is being made available to all U.S. states and territories and represents important steps in achieving the Environmental Protection Agency's National Recycling Goal and Food Loss and Waste Reduction Goal. Funded activities include improving post-consumer materials management programs through developing or updating solid waste management plans and strengthening data collection efforts. From May 1 - October 31 this year, during turtle nesting season, the County hosted "Turtle Talk Tuesday". Each week, important messages were released about sea turtles, sea turtle nesting and sea turtle protection, in an effort to raise awareness. When the season ended, we reached out the President of the Amelia Island Sea Turtle Watch to get statistics about the overall season.

The basic, preliminary data was as follows:

There were 245 total nests on Amelia Island 138 were in the county 107 were in the city

Of the 245 total nests on Amelia Island 229 were loggerhead 16 were green (a record number)

Of the 138 nests in the county 15 were green

Of the 107 nests in the city 1 was green

There were 276 total false crawls on Amelia Island 161 were in the county 115 were in the city

Of the 276 false crawls on Amelia Island 247 were loggerhead 29 were green

Of the 161 false crawls in the county 27 were green

Of the 115 false crawls in the city 2 were green

The total number of eggs laid on the island equals 18,906.

Of that total, 18,298 emerged on their own and crawled to the water.

"So much goes into our work. This is only a small, preliminary snapshot of our efforts", stated Mary Duffy. "The Amelia Island Sea Turtle Watch, Inc. would like to thank Nassau County for their support throughout the season. Turtle Talk Tuesday has been a great educational tool for our residents, and we appreciate the effort".



\*A request for legal services is an internal form that staff uses to request the County Attorney to provide legal advice and/or review documents prior to items being presented to the Board of County Commissioners for consideration.



Pursuant to recent amendments to Section 125.66, Florida Statutes, beginning October 1, 2023, Nassau County must prepare a business impact estimate when adopting an ordinance. The Statute contains exceptions, however, for the adoption of most ordinances, a business impact estimate will be required.

The business impact estimate must be published on the County's website and include (1) a summary of the proposed ordinance including a statement of the public purpose, (2) an estimate of

the direct economic impact that the proposed ordinance will have on private, for-profit businesses in the County, (3) a good faith estimate of the number of businesses likely to be impacted by the ordinance and (4) any additional information the Board of County Commissioners determines to be useful.

The County Attorney's Office has prepared a form for use by the County's Departments which is available on the County's Attorney's Office page on the intranet. The County Attorney's Office is always available to assist with questions regarding the same.



## Succesful Household Hazardous Waste Recycling Event

Twice a year, Nassau County Solid Waste and Keep Nassau Beautiful partner to host the Household Hazardous Waste Recycling Event. This event provides an avenue for residents to safely dispose of items that are too hazardous for the landfill. Examples include: electronics, power tools, batteries, fluorescent lightbulbs, oil/lubricants, pesticides, latex paint, gasoline, propane tanks, and more.

### **COUNTY TOUR WITH VISION TEAM**

Several members of the Planning Department spent two half days touring Nassau County with the consultant team responsible for drafting the 2050 Vision Plan. The team focused on the eastern side of the County on the first day and the western side on the second day. Sites visited on the first day included the North End/Dee Dee Bartels Boat Ramp, the Peck Center, Bosque Bello Cemetery and Old Town Fernandina Beach, Centre Street, American Beach, Nassauville/Holly Point Boat Ramp, Amelia Concourse neighborhoods, Pirate's Wood, Chester, Hedges, the William Burgess District, and Wildlight. Sites included on the second day included Evergreen, Lessie, Kings Ferry, White Oak, Kolars Ferry, Boulogne, Hilliard, Callahan, Bryceville, Italia, Tributary, Timbercreek, Plummer Creek, and the Northeast Florida Fairgrounds.

The Vision Plan will be drafted over a period of 16-20 months with multiple opportunities for public input and engagement.

Note: In 2024, the County will embark upon an exciting and critical County-wide visioning exercise which will be the basis of the County's rewrite of its Comprehensive Plan. The Visioning Process will be transparent, engaging and extensive in an effort to reach as many community members as possible. Residents are urged to take part in this process and make your voice heard as we begin preparing for the future.

Construction from Middle Road to US 17 (Phase 1) is nearing completion. Construction from Bay Road to Middle Road (Phase 2) is also nearing completion.

Henry Smith Road Improvements: Construction anticipated to begin in December 2023.

Pratt Siding Road Improvements: Plans are complete. Right-of-Way identification and acquisition is currently underway.

William Burgess Blvd: Final permitting and specification are nearing completion. Construction expected to begin in January 2024.

## **County Road 121 Improvements:**

The design for the segment between Duval County to CR 119 began in April 2023. The design timeframe will be 9 months. Construction is expected to commence in early 2024. The County will be issuing an RFQ soon for the segment from CR 119 to US 1 in Boulougne.

#### **Hendricks Road Extension**

Right-of-way acquisition is nearly complete. Design to begin in the last quarter of 2023.

## **Bicycle and Pedestrian Projects**

#### **Amelia Island Parkway Trail: Phase One**

Construction by CGC, Inc. is underway. Expected completion is May 2024.

#### **Amelia Island Parkway Trail: Phases 2-4**

Phase 2 design was completed in the first quarter of 2023. The advertisement for construction is expected in late 2023. Phases 3 and 4 are under design.

## Amelia Island Trail from Simmons Road to Hickory Street

This segment was funded by legislative appropriations from the State. The County grant agreement was executed and staff is preparing to advertise for design professional services. The RFQ will be advertised in November 2023.

#### **Citrona Drive Pedestrian Improvements**

Construction was completed in August 2023.

## **Intersection Improvements**

### Pages Dairy and Chester Road Intersection Improvements

Design is nearing completion and construction is expected to begin in January 2024.

## William Burgess Boulevard and Harts Road Roundabout

Design is complete. Construction will be completed under a development agreement with costs shared by the developer and the County. Construction is expected in late 2023.

## **4-H Youth Development**



### **AGRICULTURE**

The Ag/Natural Resources Agent works to help ranchers and farmers enhance their production and distribution capacities, while maintaing sound environmental principles.

#### **Success Story**

David Hebert, the Ag/NR Extension Agent with Nassau County, taught at the Silvopasture Workhsop during Forest Week at the Florida Forest Service Event in Hilliard this past Friday, October 27th. With about 20 people in attendance, David when over the types of forages available to plant during the warm and cool seasons and different methods of planting. He showed attendees different graphs with one goal in mind: Reduce the amount of "purchased" and "stored" feed - that is to reduce the cost associated with buying feed rather than growing it on-site. The latter option presents the property owner with more options and enables them to save money while maximizing land use and animal health. The workhsop explained the benefits of silvopasture and how it improves the quality of livestock and livestock products.

## **Family & Consumer Sciences**

The Family and Consumer Sciences Agent works with residents and families on solving problems related to nutrition, food safety, food preservation and storage, wellness, financial management, and more.

#### **Success Story**

Nassau County Extension's Family and Consumer Sciences division recently made a significant impact on the life of a 78-year-old resident. The Extension Agent met with the resident to explore her 2024 Medicare Drug plan options. The Extension Agent provided unbiased assistance to the senior resident, helping her navigate the often complex world of Medicare Drug plans. Through this collaborative effort, the resident managed to reduce her annual out-of-pocket expenses by an impressive \$800.

During their meeting, the resident shared concerns about her granddaughter, who worked as a food server and did not have health insurance. The agent informed the resident about the existence of the marketplace insurance and offered a list of local insurance companies. This valuable information provided the resident with the means to guide her granddaughter towards obtaining the health insurance she needed.

Finally, the Extension Agent went the extra mile by providing the resident with an application for the Florida Property Tax Senior Citizen discount. This discount equates to an additional \$50,000 exemption on property taxes, which can make a significant difference in a senior's financial situation. The resident took action and applied for this discount.





