

**A PROCLAMATION OF THE NASSAU COUNTY BOARD OF  
COUNTY COMMISSIONERS, CELEBRATING NASSAU COUNTY  
COUNCIL ON AGING’S 50<sup>TH</sup> ANNIVERSARY**

**WHEREAS**, Nassau County Council on Aging was formed in February 1974; and

**WHEREAS**, Nassau County Council on Aging is a non-profit 501(c)(3) with a mission to enhance the lives of older adults through services and compassionate care designed to improve the health, independence and economic security of all Nassau County seniors and their families; and

**WHEREAS**, Nassau County Council on Aging has matched the senior population growth in Nassau County with seniors comprising nearly 30% of our county with 8-11% of seniors living at or below poverty level; and

**WHEREAS**, Nassau County Council on Aging’s programs enable those 60 and older to live independently at home while also providing opportunities for socialization, and activities geared toward the needs of seniors; and

**WHEREAS**, Nassau County Council on Aging’s early services met seniors’ immediate needs such as household chores, meals, and transportation; and

**WHEREAS**, Nassau County Council on Aging currently delivers critical services in several categories such as Nutrition, Adult Day HealthCare, Advocate Home HealthCare, Transportation, CHORE (small home repair), Support Groups, Educational Platforms, Senior Life Centers and Volunteerism; and

**WHEREAS**, Nassau County Council on Aging receives funding through federal, state and local grants as well as donations from corporations and individuals; and

**WHEREAS**, in 2022, Nassau County Council on Aging provided more than 45,000 meals to seniors, assisted with 22,000 hours of personal care, companionship, shopping and caregiver respite, provided 52,000 trips with 23 vehicles, and had nearly 300 volunteers provided 10,274 hours of service to Nassau County seniors; and

**WHEREAS**, Nassau County Council on Aging has received the Bank of America's Neighborhood Builders award for Northeast Florida, been named Nonprofit of the Year by the Nassau County Chamber of Commerce, and has received the Community Service Award from the Fernandina Beach Police Department; and

**WHEREAS**, Nassau County Council on Aging is looking forward to its next 50 years of providing targeted services of comprehensive, compassionate care that not only foster independence, but also help clients remain active, valued members of the community; and

**WHEREAS**, the Nassau County Council on Aging will celebrate its 50<sup>th</sup> Anniversary on February 15, 2024.

**NOW, THEREFORE, BE IT PROCLAIMED** that the Board of County Commissioners of Nassau County, Florida, on this 12<sup>th</sup> day of February 2024, hereby extends its sincere congratulations to Nassau County Council on Aging on their 50<sup>th</sup> Anniversary and thanks them for their long-time service and dedication to the residents of Nassau County, Florida.
