 - Each member county is allocated two votes at Board of Director meetings.
 - The individuals designated by the commission will be recognized as the credentialed representatives from each county regarding Small County Coalition voting procedures.
 - If the designated commissioners are not able to attend meetings other Commissioners in attendance will be recognized as having voting privileges.
 - **IMPORTANT** - Only Individuals listed as Commission Representatives are eligible to be nominated for SCC Officer and Executive Committee when election occur at the Annual Meeting after the legislative session.
 - All commission members can attend any meeting that is held by the Small County Coalition.
