

**AMENDMENT NUMBER 3/THIRD EXTENSION TO THE AGREEMENT
FOR MEDICAL SUPPLIES**

THIS AGREEMENT entered into this ____ day of _____, 2017 by and between the **BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA**, a political subdivision of the State of Florida, (hereinafter referred to as "County") and **QUADMED, INC.** located at 11210-1 Philips Industrial Boulevard, Jacksonville, FL 32256; (hereinafter referred to as "Vendor").

WHEREAS, the parties entered into an agreement on March 24, 2014 for the purchase of Medical Supplies; and

WHEREAS, the original agreement provided for an initial term beginning March 24, 2014 and ending March 23, 2015 with an option to renew for three additional one year periods;

WHEREAS, the parties agreed to extend the agreement for the periods beginning March 24, 2015 and ending March 23, 2017; and

WHEREAS, the parties desire to amend and extend said Agreement.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

1. The performance period is hereby extended for an additional period beginning March 24, 2017 and ending March 23, 2018.
2. Line Item Pricing under Attachment "A" shall be amended as follows:
