Discussion: Mr. Stankiewicz stated that this is the first of many budget discussions. He noted that all the departments' budgets are due by April 21, 2017. This presentation is to provide the Board with information regarding the budget process and receive direction from the Board. He provided a PowerPoint presentation recapping property tax values from 2007 through his projected 2018 values which included a five percent increase in the property tax values; Ad Valorem Tax Revenue; millage rankings in the State of Florida; and Nassau County's financial condition per Purvis Gray and Company. Mr. Stankiewicz then reviewed the Florida Auditor General financial indicator data. Purvis Gray and Company is required to complete the analysis each year. He also touched upon inadequate infrastructure, restricted funds, and increasing the millage rate.

Mr. Pope discussed the impact that recreational parks would have on the county. He also distributed additional information.

Mr. Stankiewicz addressed the gas tax (user fee). The group discussed not having a plan in place to address the needs of the county in the event of an emergency; paving dirt roads with the funds from the gas tax; whether the county has received funds from FEMA; and cost to pave a mile of dirt road.

Noted: Mr. Stankiewicz will try and bring back at the next budget meeting an estimate of the number of vehicles that use the county's gas pumps that do not live in Nassau County.

Ms. Jones responded to an inquiry regarding paying off the County bonds. She commented on several options for the use of the reoccurring bond payment once the bond is paid off. Mr. Stankiewicz recommended long term debt for long term assess. Discussion continued regarding a multi-year budget and whether the county has any open space to create a trail similar to the Greenway.

Ms. Jones commented that the county has no financial problem as far as meeting the operating bills. She expressed concern whether the level of service is sufficient. The group discussed setting a workshop to identify the needs of the county.
