COMMENCE AT THE NORTHWESTERLY CORNER OF LOT 1, BLOCK 13, UNIT 2 OF AMERICAN BEACH, SECTION 3, RECORDED IN PLAT BOOK 4, PAGE 1, OF SAID PUBLIC RECORDS, SAID POINT ALSO BEING THE INTERSECTION OF THE SOUTHERLY R/W LINE OF LEWIS STREET, (A 60 FOOT R/W, AS NOW ESTABLISHED), WITH THE EASTERLY R/W LINE OF STATE ROAD A-1-A (A 200 FOOT R/W AS NOW ESTABLISHED), RUN THENCE SOUTH 02 DEGREES 19 MINUTES 50 SECONDS WEST ALONG THE SAID EASTERLY R/W A DISTANCE OF 193.50 FEET, TO THE POINT OF BEGINNING.
