The enclosed is information for pursuing a domestic name designation with USGS GNIS system and to request preferred last line status with the USPS for Wildlight.

This simply allows the postal service to recognize Wildlight in the last line for postal delivery purposes. We have shown this area to be the central and southern planning areas of DSAP #1 that is the potential larger footprint of the Wildlight and syncs up with the entitlement areas that are proximate, i.e. excludes the northern planning area since it's far removed.

A no objection letter is being requested by the BOCC to facilitate our request to the USGS. Additionally they request contact information for an authority in the local government to be called upon to verify or confirm certain information. I intended to submit your contact information or your chosen delegate. This letter and contact information will be uploaded in the application to the USGS.

I've also drafted letter that would come from you or your delegate to the USPS to formally request the preferred last line designation with the USPS.

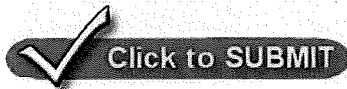
