Mr. Mullin read the legislative procedures for Tab P, S, U, and V.

**Discussion:** Mr. Stankiewicz reviewed the benefits of the Five Cent Gas Tax. He commented that the gas tax would generate \$1.8 million dollars; of that portion eighty-five (85) percent goes to the Board of County Commissioners; nine (9) percent would go to the City of Fernandina Beach; four (4) percent would go to the Town of Hilliard, and less than one (1) percent would go to the Town of Callahan. Mr.

Stankiewicz clarified that the funds could only be used for transportation related expenditures which are capital in nature. He provided feedback from the outreach meetings held and addressed various complaints regarding citizen's lack of trust in government (not just local government), how the funds will be spent, and how the project will be prioritized. The group discussed the term of the gas tax, and the number of miles of dirt roads in each district.

Shirley Graham, former Town of Callahan Mayor, came forward to address her concerns regarding the language in the ordinance as it relates to dirt roads. She also addressed the price of gas on the west side versus the east side of the county. Ken Bass, Town of Callahan Councilman, came forward to address funding for the roads on the west side of Nassau County.

Mr. Stankiewicz responded to an inquiry regarding the pay off of a bond in October 2019. Mr. Mullin commented that staff could craft language on priorities which would provide the board the satisfaction they are looking for. Mr. Stankiewicz commented that staff would agree to some kind of accountability, whether it be monthly or quarterly reporting on the County website, or bringing it back to the Board.

No less than sixty percent of the funds shall be allocated by the Board of County Commissioners west of I-95. Mr. Mullin suggested adding language to state "The priorities/allocations can be amended without a majority plus one vote of the Board of County Commissioners." The only other item to address is the term for the Gas Tax Ordinance.

Mr. Stankiewicz responded to an inquiry that the sixty percent (60%) is estimated at \$960,000.00 and the balance would be approximately \$640,000.00.

She felt that consideration should be given to some data-driven analysis, an engineering study to the condition of the dirt roads, and emergency services.
