Jon Lasserre, attorney with Rogers Towers, came forward to address his client's proposal, to allow off premise consumption in the A1A Overlay District. His client is willing to wait for a comprehensive solution to this issue.

Mr. Mullin suggested that he and Mr. Pope prepare a draft alcohol ordinance, in conjunction with the County Manager to bring back to the Board for their consideration within thirty days. He would prefer a day meeting in order for the Board to discuss what aspects of the ordinance they might want to change. Discussion followed.
