- October 1, 2017 through September 30, 2018, unless terminated by either party upon thirty (30) days written notice to the other party, subject to completion of all previous and outstanding billings.
- 2. The funding for Fiscal Year 2017-2018 shall be One Hundred-Fifty Thousand Dollars (\$150,000.00), which shall be paid in quarterly installments of Thirty-Seven Thousand Five Hundred Dollars (\$37,500.00), during the months of December, February, May and August of the fiscal year.
- 3. All other provisions of the Agreement not in conflict with this Amendment shall remain in full force and effect.
- 4. Time is of the essence.
