following recommendations: Motion: Approve the (1) the Chairman a letter Authorize to execute the Stewardship District and Raydient that indicates that the Board does not concur with the Engineer's [ETM] report and WH & Associates' report. (2) Re-affirm and re-states that this is a public/private partnership. The public/private partnership, in the past, has meant, consultation, coordination and cooperation with the public partner. (3) Overall planning approach should be, as originally set based upon consultation, coordination cooperation prior to submission of documents, this should apply to the Stewardship District as well. (4) Regularly scheduled reports, by County staff, to the Board of County Commissioners on ENCPA issues-suggest every 120 days. (5) Continue the Memorandum of Understanding (MOU) negotiation process with Raydient and request that the MOU negotiations

Stewardship District representative include a negotiations and require all parties to be a signatory. The MOU should address, among other items, public facilities and recreation and funding. (6) Staff [including Planning and Zoning Department, Engineering Department, the County Attorney and County Manager, or designee] should schedule regular meetings between representative of the Stewardship District and Raydient. Follow up after each meeting. (7) Restate the principals set forth in the Raydient handout that "the growth within these lands (ENCPA) pays for itself and does not burden Nassau County or its taxpayers." Raydient and Stewardship District representative should provide to County staff annual monitoring reports.
