Dear Mr. Leeper,

We are getting started early again this year and the 23rd annual Amelia Island Concours d'Elegance is set for Thursday, March 8th, through Sunday, March 11th, 2018, at The Ritz-Carlton and Golf Club of Amelia Island. As in past years, we have sincerely appreciated the cooperation of Nassau County and all of the residents. We are asking for additional time to use half of the Peters Point area, as the show has grown and we do not want to cause any issues with trucks and equipment being at Peters Point for a longer period of time. We now start building on the Golf Club of Amelia Island starting Monday, February 26.

We request from Nassau County:

1. The use of one half of Peter's Point from 6:00 a.m., Monday, March 5th through Wednesday, March 7th at 11:59 a.m.
2. The use of all of Peter's Point (with exception of the handicapped spots) from 12:01 p.m., Wednesday, March 7th, 2018, through Monday, March 12th, 2018, at 11:59 a.m. As in prior years, this will provide parking for show car transport vehicles and create access to the show field for show cars that are not street legal. Additionally, as in past years, the access road to the beach would remain open to the public and handicapped spaces would still be available to the public. The Concours would provide the necessary temporary barriers to ensure that traffic flows smoothly onto the beach.
3. The use of Scott Road Beach Access parking area from 8 a.m., Thursday, March 8th, 2018, through Sunday, March 11th, 2018, at 8 p.m. This would be used by Media and Vendors and we would have a CSC Security guard manning it. We will keep 15 spaces open and available for the public use as well as the access road to the beach.
4. The approval for the Concours Foundation to install, on County property, a temporary six-foot, chain-link fence. This will extend from the drive entering The Ritz-Carlton, east of the sidewalk on A1A around to the Summer Beach pool and on to the Carlton Dunes wall in Peter's Point. This will prevent unauthorized access to the show field.

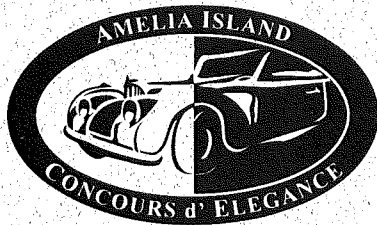
As in the past, we will supply Nassau County with a Hold Harmless Agreement.
