WHEREAS, the parties entered into an extension period beginning August 1, 2017 and ending July 31, 2018; and

WHEREAS, there is a need to modify the scope of work to address the issue of replacement of trees, shrubs, as well as other items which was not included in the original scope of work. The Vendor would be considered a single source to provide these services in order to meet certain

functional/performance and continued maintenance requirements.

WHEREAS, the parties desire to amend and extend said Agreement.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

- 1. In accordance with Section 11 of the Agreement for Landscape Maintenance for Amelia Concourse MSBU dated July 16, 2014, the scope of work shall be modified to include additional services for the replacement of trees, shrubs, and other items, as detailed in the revised Exhibit B Technical Specifications/Scope of Work, Part 7.
- 2. The performance period for these additional services shall begin upon the date first written through the term of the agreement, including any renewal periods.
- 3. All other provisions of said Agreement not in conflict with this Addendum shall remain in full force and effect.
