**Dirt Road Upgrades Project** 

Budget: \$ 200,000

**Estimated Completion Date: Late Winter 2018** 

**Status**: The Commission approved additional \$200k budget to perform upgrades to dirt roads throughout the County. Staff will continue hauling the material to Lang Road, Crews Creek Road, Karnchapking Road then Sheard Stokes Road beginning April 2018, however, bridge repairs, Logan Road drainage improvements and Clements Road have taken priority. Staff anticipates completion by late July 2018.

**Roadway Striping Upgrades**

**Status:**This program is designed to refurbish worn striping on our paved roads in order to provide better visibility of roadway striping to our motoring public. #### **Kinard Road Crossdrain Replacement**

**Budget: TBD** 

**Estimated Completion Date: Completed March 2018** 

**Status**: Staff replaced the failed crossdrain and sand-cement bag head walls on March 23, 2018. The project has been completed.

#### **Spring Lakes Estates Drainage Repairs**

**Status**: Six failed crossdrains were replaced within the subdivision from February 26 to March 13, 2018. The crossings were temporarily patched and approved to be overlayed as part of the Pavement Management Program for 2018.

#### **Conner Cutoff Drainage Project**

**Estimated Completion Date: Pending Right-of-Way Aquisition** 

Status: There is no outfall for drainage on Larsen Road. Staff has sought permission from the property owner to obtain a right-of-entry then Drainage Easement to open an outfall ditch and reset the roadside ditch drainage and culverts. Verbal approval has been obtained and the property owner is reviewing the language of the right-of-entry.
