This letter serves as the accounting of my annual financial report for the fiscal year ending September 30, 2018 as required by Section 218.36 of the Florida Statutes.

According to the accounting, there are remaining funds that represent the amounts received over the amounts expended for the fiscal year. These remaining funds are being returned to the county.
