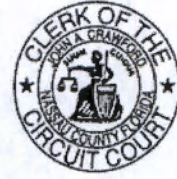


Dear Mr. Murphy:

In the interim, if I can be of any service to you, please let me know.

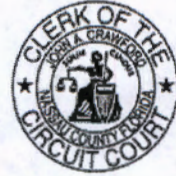
